AN ACT TO ADD A NEW CHAPTER 26, AND NEW §§5122 AND 5B105, TO TITLE 17, GUAM CODE ANNOTATED, RELATIVE TO PROFESSIONAL EDUCATOR CERTIFICATION.

1 BE IT ENACTED BY THE PEOPLE OF GUAM:

- Section 1. A new Chapter 26 is hereby added to Title 17, Guam Code
- 3 Annotated, to read:
- 4 "Chapter 26. Guam Commission for Educator Certification
- 5 §26000. Legislative Intent. I Liheslaturan Guåhan finds that the goal of
- 6 Educator Certification is to determine whether those individuals responsible
- for the education of children are competent to perform their duties as
- 8 teachers, guidance counselors or school administrators.
- 9 I Liheslaturan Guåhan further finds that throughout the United
- States, the certification or licensure of educators is a function that occurs at
- the state level and not in the local school districts that employ the educators.
- The common practice is for states to define the Educator Certification or
- 13 Licensure standards by means of a Board or Commission to include local
- and federal education mandates. Such Boards or Commissions also will set

up an office(s) in the state to certify and license education professionals who qualify. These Boards or Commissions are also responsible for determining improper conduct by the certificate holder or licensee is sufficient to warrant revocation or suspension of such license or certificate.

It is the intent of *I Liheslaturan Guåhan* to provide a mechanism to confer professional certification for *Early Childhood to Twelfth* (12^{th}) grade educators via an external entity that is separate and apart from the entities that employ such educators.

§26001. Purpose. (a) The purpose of this Chapter is to establish a system of professional development, professional standards, certification and evaluation that serves to continually improve the quality of instruction for Guam's children so that they are equipped to work and succeed in an ever-changing and increasingly complex global economy. The Guam Commission for Educator Certification is established to provide a rigorous system of certification, professional development and evaluation designed to support improved student achievement and to improve the quality of the Guam educator workforce and to improve student performance. All Guam Public School System educators must be certified and evaluated in accordance with this Chapter. The Board shall regulate and oversee all aspects of the certification, continuing education, and standards of conduct of public school educators.

- (b) In proposing rules under this Subchapter, the Commission *shall* ensure that all candidates for certification *or* renewal of certification demonstrate the knowledge and skills necessary to improve the performance of Guam's diverse student population.
- §26002. Definition. In this Subchapter, 'Commission' means the Guam
 Commission for Educator Certification.

1	§26003. Guam Commission for Educator Certification. (a) There is
2	hereby established the Guam Commission for Educator Certification to consist of
3	seven (7) voting members appointed by I Maga'lahen Guåhan with the advice and
4	consent of I Liheslaturan Guåhan, as specified in subsections (1) to (5), inclusive.
5	The Commission shall consist of the following members:
6	(1) a classroom teacher employed in a public school;
7	(2) an administrator (principal or assistant principal) employed in a
8	public school;
9	(3) a guidance counselor employed in a public school;
10	(4) two (2) members who possess a terminal degree in the subject
11	of education from an accredited college or university which, as used
12	herein, means an institution that is accredited by a United States
13	accrediting body recognized by the Council on Higher Education
14	Accreditation (CHEA) or its successor, or an equivalent foreign
15	college or university; and
16	(5) two (2) members appointed from the community at large.
17	(b) Appointments to the Commission shall be made without regard to the
18	race, color, disability, sex, religion, age, or national origin of the person
19	appointed.

20 (c) A Commission member is immune from civil suit for any act 21 performed in good faith in the execution of duties as a Commission member.

(d) Members *shall* serve a term of three (3) years and may be reappointed, provided that the member continues to meet the employment criteria in the event that such member was appointed to fill a seat on the Commission pursuant to Items (1), (2) and (3) of Paragraph (a), supra.

If a member is appointed pursuant to Items (1), (2) and (3) of 2 Paragraph (a), supra, and ceases to be employed as such, that member shall be considered to have vacated his or her seat effective on the date that such 3 4 employment was terminated. If a member is absent from any four (4) regularly

scheduled meetings in any calendar year, his or her office as a member of the

Commission shall be deemed vacant. The Chairperson of the Commission shall

forthwith notify *I Maga'lahi* that the vacancy exists

- (f) The Superintendent of Education or his designee, the Chairman of the Guam Education Policy Board or his designee, the President of the Guam Community College or his designee, and the President of the University of Guam or his designee, shall serve as ex-officio member, without vote in proceedings of the Commission.
- 13 **Terms:** Vacancy. In the event of a vacancy, I Maga'Lahen 14 Guåhan shall appoint a replacement in the same class of the member that vacated his or her position on the Board for a term of three (3) years. 15
 - §26005. Officers. The Commission shall elect one (1) of its members to serve as presiding officer for a term of two (2) years. The presiding officer is entitled to vote on all matters before the Commission. The Commission may elect other officers from among its membership.
 - **§26006.** Compensation. A Commission member shall receive compensation for serving on the Commission in the amount of Fifty Dollars (\$50) for each Commission meeting attended. A member is entitled to reimbursement for actual and necessary expenses incurred in performing functions as a member of the Commission, subject to any applicable limitation on reimbursement provided by the General Appropriations Act. The compensation of the members of the Commission who are public employees shall not be reduced by the agency or

2	occasioned by attendance upon the business of the commission, its committees or
3	subcommittees.
4	§26007. Meetings. The Commission shall meet as it deems appropriate
5	and necessary to accomplish its duties, but shall meet no fewer than once each
6	quarter.
7	(a) The Commission shall meet at least once in each quarter of the
8	calendar year.
9	(b) The Commission may meet at other times at the call of the
10	presiding officer or as provided by the rules of the Commission.
11	§26008. General Powers and Duties of the Commission. The
12	Commission shall:
13	(a) supervise the executive director's performance;
14	(b) approve an operating budget for the Commission and make a
15	request to I Liheslatura for appropriations;
16	(c) appoint members of any advisory committee to the
17	Commission;
18	(d) for each class of educator certificate, appoint an advisory
19	committee composed of members of that class to recommend standards for
20	that class to the Commission;
21	(e) provide to its members and employees, as often as necessary,
22	information regarding their qualifications for office or employment under
23	this Chapter and their responsibilities under applicable laws relating to
24	standards of conduct for state officers or employees;
25	(f) develop and implement policies that clearly define the
26	respective responsibilities of the Commission and the Commission's staff;

1 (g) file annually with I Maga'lahen Guåhan and the Speaker of I Liheslaturan Guåhan a complete and detailed written report, in the form and 2 3 within the time provided by the General Appropriations Act, accounting for all funds received and disbursed by the Commission during the preceding 4 5 fiscal year; and execute interagency contracts to perform routine administrative 6 (h) 7 functions. **§26009.** 8 Place of Commission Meetings. The Chairman shall 9 designate an appropriate location for each Commission meeting. Notice of 10 such locations shall be given pursuant to the provisions of Title 5, GCA, 11 Chapter 8. 12 §26010. Emergency Meetings. An emergency meeting of the Commission 13 may be called by the Chairman. Notice of such meeting shall be communicated in the manner most likely to give the greatest amount of notice to the members: 14 15 phone, facsimile, mail, or email. Notice to the public of emergency meetings shall 16 be given pursuant to the provisions Title 5, GCA, Chapter 8. 17 §26011. Executive Sessions. Executive Sessions of the Commission are closed meetings which may be held only as expressly authorized by Title 5, GCA, 18 Chapter 8. Persons who may attend and subjects that may be discussed are also 19 20 described in Title 5, GCA, Chapter 8. 21 §26012. Agendas. The Chairman and the Executive Director determine the agenda for a Commission meeting. Final approval of the agenda lies with the 22

Commission Chairman. Commission members should receive the agenda and

supporting materials for an upcoming meeting at least ten (10) calendar days prior

to the meeting when possible.

1	In the event the agenda and/or supporting materials cannot be delivered at
2	least ten (10) calendar days prior to the meeting, the Executive Director shall
3	notify the Commission as to the reason why. The Commission Chairman will
4	timely provide other Commission members the reason for removing an agenda
5	item after it has been posted.
6	§26013. Quorum and Carrying Actions of the Commissions. A quorum
7	shall consist of four (4) voting members. Actions of the Commission shall be
8	carried by a vote of not less than four (4) voting members.
9	§26014. Signature Authority for Commission Disciplinary Orders. The
10	Chairman may sign on behalf of a majority of the Commission a decision or order
11	issued in a disciplinary case relating to Commission disciplinary proceedings,
12	including enforcement of the educator's code of ethics. Members of the majority,
13	however, retain discretion to sign any decision or order.
1.4	§26015. Communications. The Chairman and the Executive Director

19	GCA, Chapter 9. Such Rules and Regulations may be revised as needed consistent
20	with the provisions of Title 5, GCA, Chapter 9.
21	§26017. Relationships with the Public. The Commission shall develop
22	and periodically review policies regarding the following:
23	(a) Policies and procedures for stakeholder input on rule
24	development.
25	(b) Policies and procedures on accepting public testimony.

1	§26018. Executive Director and Commission Staffing. The Commission
2	shall hire an Executive Director to manage the daily operations of the
3	Commission. Such employment may be in either, (a) the unclassified service or
4	(b) by employment contract. The term of employment shall not exceed five (5)
5	years, but may be renewed by the Commission, after expiration, for successive
6	terms. Compensation and job qualifications shall be established by the
7	Commission. The Commission shall create a staffing pattern for additional staff
8	required for the operations of the Commission. The staff shall be classified
9	employees hired pursuant to the merit provisions of Title 4, GCA, Chapter 4. The
10	staff shall include, but not be limited to, those classified employees who
11	transferred from the Guam Public School System Certification Office during the
12	transition to the Commission.
13	§26019. Relationship of the Commission to the Executive Director

8	certification applications that commence when all required valid and authentic
9	documents are received.
10	§26026. Prior Certification Standards. All certification standards and
11	requirements adopted by the Guam Education Policy Board prior to the enactment
12	of this Chapter shall remain effective unless they are amended or repealed by the
13	Commission in a manner consistent with the provisions of this Chapter."
14	Section 2. A new §5122 is hereby added to Title 17, GCA, Chapter 5, to
15	read as follows:
16	"§5122. Applicability of this Chapter for Certification of GPSS
17	Educators. The Commission shall be the Educator Certification authority
18	for all Guam Public School System Educators no later than the earlier of the
19	completion of a transition period following the enactment of this Chapter or
20	October 1, 2008."
21	Section 3. A new §5B105 is hereby added to Title 17, GCA, Chapter 5B,
22	to read as follows:
23	"§5B105. Applicability of this Chapter for Certification of
24	Reading Specialists. The Commission shall be the Educator Certification
25	authority for Reading Specialists no later than the earlier of the completion

1	of a transition period following the enactment of this Chapter or October 1,
2	2008."
3	Section 4. Transition: Legislative Findings. I Liheslaturan Guåhan
4	finds that the GPSS Certification Office operates under the direct supervision of
5	the Superintendent of Education. The staff and operations of this office are
6	funded for Fiscal Year 2008 by appropriations to the GPSS in the General
7	Appropriations Act enacted in Public Law 29-19.
8	Section 5. Transition: Period. The transition period for the transfer of
9	Educator Certification functions from the Guam Public School System to the
10	Guam Commission for Educator Certification shall begin after the date of
11	enactment of this Act and be completed no later than October 1, 2008.
12	Section 6. Transition: Process. The Superintendent of Education shall
13	cause to be created, a transition process that transfers Educator Certification
14	functions from the Guam Public School System to the Guam Commission for
15	Educator Certification. The plan may include the following:
16	(a) Support for personnel costs for those certification office
17	personnel transferred from GPSS to the Guam Commission for Educator
18	Certification for the remainder of Fiscal Year 2008 from funds
19	appropriated by Public Law 29-19.
20	(b) The physical location of the Guam Commission for Educator
21	Certification.
22	(c) Any other items that will result in a smooth transition.
23	Section 7. Transition: Guam Educator Certification Commission
24	Funding for the Remainder of Fiscal Year 2008. I Maga'lahen Guåhan is
25	authorized to transfer up to Fifty Thousand Dollars (\$50,000) from any
26	appropriations for Fiscal Year 2008 that are for the current operations of the

- 1 government of Guam, and not appropriated for debt service or encumbered by a
- 2 contractual obligation, to the Guam Commission for Educator Certification for its
- 3 operations for the remainder of Fiscal Year 2008. Such transfers are in addition to
- 4 the GPSS support for Certification Personnel transferred to the Commission and
- 5 the fees collected.
