It is recommended to the Commission that we add Family and Consumer Science (0121 – pencil and paper or 5121 computer delivered) to the Guam Praxis II – Content required tests with a passing score of 153 (Hawaii) or a recommended passing score from ETS.

Two focus group meetings were held, February 18th and February 27th. One CFS teacher attended each meeting. Neither had any objections to the addition of this test to the GCEC requirements. CFS teachers were contacted prior to each meeting inviting them to participate.
