

Appeal to the Guam Commission on Educator Certification for a special endorsement of Driver Education on the Master Educator Certificate in Science for Vincent J. Eblacas

Public Law 27-100 designates the Guam Department of Education as the Agency responsible to certify Teachers in Driver Education. It enacted Title 16 Chapter 3 Section 3113 which requires a secondary teacher certificate to be issued by the Department of Education with an endorsement in Drivers Education or a certificate to teach driver education from a recognized educational institution or training agency in Guam; or from another territory or state which has Driver's Education Training; or a safety education minor or major from a United States accredited Institute of Higher Education (IHE).

Driver Education is still on the official course offerings for high school for the 2013 Board Approved High School Courses. The official 2013 Board Approved course offerings for High School remains unpublished due to technical difficulties. It is under TS101 Driver Education and describes what Better Drivers and UB Safe Driving do as private businesses, which are to provide the training to become a licensed driver in Guam. Eloise Sanchez (esanchez@gdoe.net) or Sylvia Calvo (stcalvo@gdoe.net) at Curriculum and Instruction can be contacted to verify that the Driver Education course is still on the official courses offered in High School. The 2003 Board of Education approved high school courses booklet is on file at UB Safe Driving. I know which courses are offered at the high school level because I was the Vice Chair of the Joint Board Union Curriculum and Textbook adoption Committee (JBUCTC) from 2000 to 2003 and am currently the Vice Chair of the JBUCTC after rejoining that committee in 2011.

The approved curriculum book for the Guam Department of Education Driver Education Program 1993 to 1994 is on file at UB Safe Driving and establishes the Guam Department of Education as being agency responsible for driver education and instructor certification.

Public Law 31-50 transferred certification authority to the Guam Commission for Educator Certification as specified in Title 17 Chapter 27 Section 27021 and title 17 Chapter 5 Section 5112.

Title 17 Chapter 5 Section 5103 (a) allows the granting of certifications for supplementary schools for adults and kindergartens.

In Public Law 31-50, under section 8104 (d) Examination of Specialization or Content Area Knowledge: Where applicable, candidates for Guam Professional Educator Certification shall pass an appropriate test for content area knowledge. Where no content area test has been approved by the Commission, Guam's content passing score shall be the Praxis II test passing score adopted by the State of Hawaii or a score reflecting eighty percent (80%) pass rate of the average maximum range respectively. Attached is the Praxis II scores in Driver Education (0867) indicating a score of 177 out of 200 possible for Vincent J. Eblacas. The passing scores are 149 for AL (Alabama), 160 for AR (Arkansas), 167 for IA (Iowa), 141 for WV (West Virginia) and 165 for WY (Wyoming). These are the states listed as accepting the Praxis II test for Driver Education.

Also under the same section (o) related work experience: A statement signed by an appropriate authorized official or a school district or other employing agency shall be the basis for determining the experience qualifications of an application for certification. UB Safe Driving is a valid employing agency in Driver Education as stated in the Articles of Incorporation for UB Safe Driving which was approved by the Department of Revenue and Taxation.

I, Vincent J. Eblacas have worked under the direct supervision of George J. Freese (who has been a certified teacher in driver education since 1993) from July 2008 to present, assisting in conducting the AARP(American Association of Retired Persons) Driver Safety Program. The AARP Driver Safety Program was officially recognized in EC Resolution 168 of the 2008 Legislature as being established in 2007. I became qualified to conduct the Driver Safety Program in the summer of 2011 after taking the official coursework via teleconference at the University of Guam on July 15th and 16th 2011, with George J. Freese, Vinacio and Maria Atalig, Janie Nauta, Dr. John C. Salas and Robert G. Cruz . Esq. from AARP trainers Frank and Carol Deuel. The invoice for this training videoconference from Professional and International Programs Telecommunication and Distance Education Operation (TADEO) is on file at UB Safe Driving. This training was officially recognized in Legislative Resolution Number 650-31 (LS).

I was also employed under Better Drivers and under the direct supervision of George J. Freese (who also worked for Better Drivers at the time) from November 2008 to November 2011. From December 2011 January 2012 there was a transition of employment from Better Drivers to UB Safe Driving. I am currently under the direct supervision of George J. Freese, while working for UB Safe Driving since January 2012 to present.

There is precedence in Texas allowing a certified driving education business to train a certified teacher so that an endorsement in Driver Education can be granted. The link to the information below is:

Training for New Driver Education Instructors

The driver education industry is rapidly growing and in need of instructors who are looking for a way to earn extra money while giving back to the community. The level of instruction is demanding, but all families and roadway users in Texas deserve the peace of mind that comes with knowing that new drivers are being taught by well trained and well prepared instructors.

The certification process includes a significant time commitment outside of the classroom instruction.

This course is not one that can be completed in two weekends.

- • All trainees are required to complete Phase I and Phase II.
- • All work required for Phase I must be completed before starting Phase II.
The classroom session for Phase II can be attended after attending the classroom session for Phase I. It is not necessary to complete the outside work for Phase I to attend the classroom session for Phase II.
- • All work required for Phase II must be completed before starting Phase III.
The classroom session for Phase III can be attended after attending the classroom session for Phase I and Phase II. It is not necessary to complete the outside work for Phase I and Phase II to attend the classroom session for Phase III.

NOTE

- A good command of the English language is required.
- All trainees must be over the age of 21.
- All trainees must have at least five (5) years of driving experience. In addition, all trainees must have a clean driving record (anyone with 6 points or more cannot be licensed as a Driver Education instructor).

The specific requirements for a Driving Education Business to train a certified teacher and allow them to become a qualified driving instructor is given below. The link for the information below is

The Driver Education Teacher (DET) Certification allows an instructor to teach classroom and behind the wheel lessons within TEA (Texas Education Agency) limitations. These instructors must have a valid Texas Teacher's Certification; however, classroom experience is not a condition for receiving a private school certificate. These are the most highly sought by private driving school directors.

All course work must be completed within 2 to 4 months.

Documentation of the following is required before beginning Phase 1:

- - Clean driving record
- - No felony convictions
- - High School Diploma or equivalent
- - College Degree/Diploma
- - Texas Teaching Certificate

Phase 1

45 Hours, Equivalent to 3 college credit hours

18 hours – Direct classroom instruction from a certified instructor.

11 hours – Independent study on specified topics to be completed outside of the classroom.

16 hours – 8 (2 hour) sessions observing in a classroom to become familiar with the curriculum of driver education.

Phase 2

45 Hours, Equivalent to 3 college credit hours

8 hours – Direct classroom instruction from a certified instructor.

14 hours – Observation of certified instructor in a car.

12 hours – Teaching in a car with a certified instructor who is observing and critiquing the trainee.

4 hours – Discussing problems and modeling procedures in needed areas.

7 hours - Independent study on specified topics.

Phase 3

45 Hours, Equivalent to 3 college credit hours

6 hours – Discussion of the trainee’s classroom instruction and the paperwork required

32 hours - 16 (2 hour) sessions of student teaching in the classroom with a certified instructor who is observing and critiquing


If *any* of the practical training is completed at another driving school in the Houston, Harris County, or Fort Bend County area, there will be a **surcharge of \$75.00** for each phase completed at such other school. Approval for such practical training must be obtained from Mr. Rosenzweig.

Mr. George J. Freese (who is a certified driving instructor under GCEC, certificate number 3980) can verify that all the previously mentioned training has been conducted by him and that I am qualified to teach Driver Education.

As mentioned before the authorized Training Agency would be UB Safe Driving (under its Department of Revenue and Taxation approved Articles of Incorporation) based on Article 2 which states that this corporation shall have as its primary purposes: To engage in, conduct, promote, advertise and carry on a driver's education business including arranging, planning and booking of classroom preparation and instruction, and road instruction leading to the ability to obtain a driver's license, professional license or other license to drive a vehicle and receive payment for said services and related activities, and to operate, maintain, manage and provide educational, instructional and technical courses including, but not limited to driver's education training.

Given all of these reasons and the need for certified teachers to conduct Driver Education on Guam I am asking that I be granted a special endorsement in Driver Education.

I, George Joseph Freese, as a duly certified teacher in Driver Education and the certifying officer of UB Safe Driving have provided training to Vincent Jay Eblacas, who is a Master Educator in Science Education grades 6 to 12, with the goal of making him a fully qualified Driver Education Instructor.

Vincent Jay Eblacas began his training in July 2008, when he assisted me in conducting the AARP Driver Safety Program. He has worked with me as a Driving Instructor at Better Drivers Driving School from November 2008 to November 2011. During July 2011, he completed the training required to become a certified instructor for the AARP Driver Safety Program. He currently works with me at UB Safe Driving as a Driving Instructor.

Vincent Jay Eblacas has shown that he is proficient in Driver Education by successfully conducting the classroom instruction required to obtain the driver's permit, by providing the on the road instruction required as part of the driver licensing process and being able to properly file the paperwork required in the licensing process.

In April 2012, Vincent Jay Eblacas passed the Praxis II Test in Driver Education with a score 177 out of 200, which provides additional validation of the training provided.


Under Public Law 27-100, a bona fide training agency may provide the training necessary to qualify a teacher to become certified in Driver Education.

Under its Department of Revenue and Taxation approved Articles of Incorporation, UB Safe Driving is authorized to conduct training in Driver Education including educational and technical courses which makes it a bona fide training agency.

Under Public Law 27-100 the Department of Education is specified as the certifying agency for Driver Education on Guam and since that authority was transferred to the Guam Commission for Educator Certification under Public Law 31-50, it is the agency responsible for granting a teacher certification in Driver Education.

Given all of the reasons above, I am recommending that the Guam Commission for Educator Certification grant Vincent Jay Eblacas a special endorsement in Driver Education as provided for under Public Law 27-100.

SUBJECT: **Protocols relative to "Responsible Boards and Commissions Education Act" (P.L. 32-031)**

Public Law 32-031 requires all Directors of which a Board/Commission is associated with to establish an Educational Program (hereinafter "EP") which covers "procurement laws, as applicable, applicable statutes, executive orders, and rules and regulations which govern the board or commission and their respective areas of purview". I have directed my staff to provide the necessary tools and instruction to assist all Board/Commission members toward reaching full compliance. As a follow up to the presentation made at the August 2nd Cabinet Meeting, this Directive provides the protocols that best comply with P.L. 32-031, which are as follows:

- A. All Directors associated with a Board/Commission would need to compile applicable procurement laws, statutes and executive orders, rules/regulations which govern your respective Board/Commission and any/all areas that your Board/Commission may have purview over. Compilation of this information must be completed by no later than August 8, 2013. This is key to complying with one component of P.L. 32-031 as this will serve as the major portion of your EP.
- B. The Governor's Office has developed a CD training instrument entitled "Basic Boardmanship Skills" which will cover the basic skill set necessary to make informed decisions at the level of each Board or Commission member. Topics

covered in the CD will include Procurement, Ethics in Government, FOIA Requests, Open Government Law, Roberts Rules of Order, etc. The training CD will be disseminated to all Boards/Commissions via each agency head by August 16, 2013.

- C. All Directors shall conduct a "Live" session with their respective Board/Commission members to ensure that they have provided their members the training materials combined in Steps A and B above (A - Agency-specific data and B - Training CD). Directors must ensure that each member reviews the training materials and understands the contents to the best of their ability. The "Live" session must be completed by September 6, 2013. P.L. 32-031 requires all members to complete the EP by September 7, 2013.

- D. All Directors must ensure that a Certification Form is completed by each Board/Commission member, which states they have completed the steps of A and C of the protocol, mentioned. Said certification form shall be filed with the Board/Commission Secretary and be made part of the record. The Certification Form for Board/Commission members certifying they have viewed contents of the CD will be emailed to the Department/Agency shortly.

- E. On or before September 13, 2013, the Director/Agency Head shall submit a written statement to the Governor, certifying that all Board/Commission members have completed the established education program as mandated by Public Law 32-031. A comprehensive report will be compiled and submitted to my Chief of Staff for his review.

Please note that P.L. 32-031 makes all Directors responsible for ensuring the completion of an Educational Program by each respective member of a Board/Commission by no later than September 7, 2013. The Governor's Office will work directly with the heads (or chairperson) of a Board/Commission not having oversight over an agency. 





**AN ACT TO ADD A NEW §43116 TO ARTICLE 1 OF
CHAPTER 43, DIVISION 4 OF TITLE 5, GUAM CODE
ANNOTATED, RELATIVE TO PROVIDING FOR
EDUCATIONAL PROGRAMS FOR MEMBERS OF
BOARDS AND COMMISSIONS.**

1 **BE IT ENACTED BY THE PEOPLE OF GUAM:**

2 **Section 1. Short Title.** This Act *shall* be cited as the “Responsible Boards
3 and Commissions Education Act.”

4 **Section 2. Legislative Findings and Intent.** *I Liheslaturan Guåhan* finds
5 that Public Law 24-191 established a single educational program at the University

1 of Guam to train members of boards and commissions. This educational program
2 was repealed by Public Law 28-76.

3 *I Liheslaturan Guåhan* further finds that, although the existence of training
4 for board members is beneficial to the operations of boards and commissions, each
5 board and commission generally has its own specific statutes and rules and
6 regulations which it must follow. Such a program should be optimized to deal with
7 matters most relevant for each board and commission.

8 Additionally, *I Liheslatura* finds that errors by the members of boards and
9 commissions can result in procurement delays, as well as litigations, which have
10 historically cost the government significant sums.

11 Therefore, it is the intent of *I Liheslaturan Guåhan* to establish training and
12 curriculum to educate members of boards and commissions on the various statutes,
13 rules and regulations which they must follow, and of which they must be aware to
14 accomplish the purposes for which each board or commission is established, by
15 adding a new §43116 to Title 5 GCA.

16 **Section 3. Boards and Commissions Educational Programs.** A new
17 §43116 is hereby *added* to Article 1 of Chapter 43, Division 4 of Title 5, Guam
18 Code Annotated, to read:

19 **“§ 43116. Boards and Commissions Educational Programs.**

20 (a) Development of Training and Curriculum. Each board or
21 commission *shall* have an educational program established to prepare
22 its members for the duties of the board or commission to which they
23 are appointed. Such educational program *shall* cover procurement
24 laws, as applicable, applicable statutes, executive orders, and rules
25 and regulations which govern the board or commission and their
26 respective areas of purview. Each educational program *shall* be
27 established, within ninety (90) days of the enactment of this Section,


1 by the Director of the agency with which the board or commission is
2 associated, or his designee; or, if there is no such agency, then *I*
3 *Maga'lahi* (the Governor), or his designee. Each educational program
4 *shall* be updated, as needed, *no less than* annually, to reflect any
5 changes to procurement laws, applicable statutes, and rules and
6 regulations. The Director of each agency *shall* report to *I Maga'lahi*
7 (the Governor) within thirty (30) days when member(s) of an
8 associated board or commission complete the applicable educational
9 program. The Director, or his designee, *shall* conduct the training
10 sessions at a time and location to be determined by the Director, in
11 compliance with the Americans with Disabilities Act and other
12 relevant statutes.

13 (b) Education of Current Board and Commission Members.
14 Each current member of a board or commission *shall* complete the
15 applicable educational program within thirty (30) days of the
16 establishment of the program.

17 (c) Education of New Board and Commission Members.
18 Each new member of a board or commission *shall* complete the
19 applicable educational program within thirty (30) days of his election
20 and qualification, or his confirmation by *I Liheslatura* to the board or
21 commission.

22 (d) Continuing Education for Board and Commission
23 Members. Each year, the members of each board and commission
24 *shall*, as a form of continuing education, complete the applicable
25 educational program for the board or commission on which they
26 serve.

1 (e) Failure to Complete an Educational Program. Failure to
2 complete an educational program within one hundred eighty (180)
3 days of a board or commission member's appointment *shall* result in
4 the member's removal and the appointment of a new member to fill
5 the vacancy, pursuant to §2101 of Chapter 2, Title 4, Guam Code
6 Annotated. Actions of a board or commission *shall not* be invalidated
7 by the failure of a member to complete the applicable educational
8 program.”
