Trip Report

The NASDTEC 96th Annual Conference was held on June 15 -17, 2025 in Charlotte, North Carolina at the Omni Charlotte Hotel.

The conference allowed time for networking with conference attendees. The highlights of the conference included how North Carolina's private businesses, through a non-profit group, invest in public schools in their state. In North Carolina, private business contribute to teacher growth, providing funding directly to schools for teacher mentors, teacher leaders, and instructional coaches. North Carolina businesses also fund programs for school administrators. This non-profit organization is given authority to work with North Carolina schools directly.

The session on Michigan's efforts to recruit teachers in hard to fill areas was impressive – Michigan state's DOE worked with the state legislature to fund many programs to help with teacher recruitment to include grow your own programs, scholarships, service incentives, and teacher loan forgiveness- all funded by the state and ARP funds. The state funds came from revenue from marijuana sales.

The highlight of the conference was the two sessions on the use of AI. The first session provided the advantages of using AI in teacher preparation. The second session presented by Fredrick Lane, presented the cons and risks of the use of Al. These presentations left the conference attendees with much to consider when implementing AI policies in educator preparation programs and in school districts.
